5. Electronic bids must be submitted to the Ministry of Health and Population, Gandaki Pokhara through PPMO's e-GP II system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hour (local time) on **April 17<sup>th</sup>, 2022 (Baisakh 04, 2079)**.
6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at **13:00 hour (Local time) on April 17<sup>th</sup>, 2022 (Baisakh 04, 2079)** at the office of Ministry of Health and Population, Gandaki Pokhara. Bids must be valid for a period of **90 days** counting from the day of bid opening. All bids must be accompanied by bid security not less than above mention table's amount, which shall be valid for minimum **30 days** beyond the bid validity period. Pre-bid meeting will be held on **7<sup>th</sup> April, 2022, 12:00 Noon (Chaitra 24,2078) at MOHP, Gandaki, Pokhara**.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
